Safeguard your assets Wills & Trusts

A Will is a legal document that specifies your wishes regarding the management and distribution of your property and belongings and the care of any minor children upon your death. You can even make provision for your pets as well as supporting charitable causes which are close to your heart.

If you do not have a Will, you die intestate and your assets might not be directed in the way you would like them to be. These laws are out of date and do not cater for modern families, for example if you are living with your partner then they will not automatically inherit from you and stepchildren are not recognised either. In addition, a carefully written professional Will can help mitigate things such as Inheritance Tax or Care Home Fees.

A Trust is a legal arrangement where you appoint a trustee to manage funds for the benefit of others. You can put money, investments or other assets into a Trust. Trusts are very often used for asset protection or to protect vulnerable beneficiaries. Trusts can be created

Prepare for ill health or injury Powers of Attorney & Court of Protection

In the future, you may need someone to make decisions or act on your behalf for a number of different reasons. If you wish to specify who you would like to manage your interests should the circumstances arise, you can set up a Lasting Power of Attorney (LPA) for either your property and financial affairs or your health and welfare, or both.

If an individual becomes mentally incapable of managing their personal affairs through ill health or injury and they do not have an LPA in place, Pardoes can help you apply to the Court of Protection to appoint a Deputy to take over the management of those affairs.

You might be hospitalised for a short period and need help managing bill payments. Or you may have a long-term illness or suffer from dementia and be glad to have appropriate arrangements in place.

Plan for later life Care home & nursing provision

We can also help you plan for the payment of Care Fees and provide advice regarding asset protection.

If you have strong views about your care, we can help set up an Advance Decision (commonly known as a Living Will), which allows you to state clearly what, if any, medical treatment and care you may wish to receive in the future.

When you lose a loved one Probate & estate administration

Probate and Estate Administration can be complex and time-consuming, it involves many legal, practical and financial matters including having to account to HMRC for Inheritance Tax. All of this comes at a time when people may not feel emotionally able to deal with additional burden following the death of a loved one and many people will struggle to cope.

A grant of probate is an official document that allows the Executors named in a Will to administer the estate in accordance with the Will. For example, if the person who died owned a house, it will be necessary to obtain probate to ensure that any sale can take place. The same will apply to distribute assets in a bank or building society if they exceed a certain amount. When someone dies without a will, then instead of a Grant of Probate a Grant of Letter of Administration will need to be applied for and administrators appointed instead of executors.
